Requirements

- 👤 **Theatrical** - Your scene should coincide with the Wells Rec theme and should have a quick storyline! Scenes must be done in good taste.
- 👤 **Lights** - Scenes must be well lit (scenes are less scary if your creepy decorations can't be seen!) You must bring your own extension cords.
- 👤 **Props** - You must supply your own props. No REAL props (i.e. blood, knives, etc.). No Chainsaws for anyone under 21.
- 👤 **Costumes** - All hunters must be dressed in full costume. A mask & sweatshirt do not qualify as a full costume.
- 👤 **Scene Supervision** - Minimum of a 1:10 ratio of Adults to Children (anyone under 18). Scene Representatives are responsible for all volunteers on your scene.
- 👤 **Volunteers** - All volunteers on your scene must check-in at Volunteer Registration when entering the park.

HAUNTED HAYRIDE RULES FOR HAUNTERS

Please make sure all of the hunters and volunteers at your scene understand and abide by these rules.

- 👤 Check in at the Rec Office upon arrival the day of the event
- 👤 **Mandatory Meeting at 3:00PM for all hunters and volunteers at the pavilion**
- 👤 NO ALCOHOL OR TOBACCO allowed on site
- 👤 Absolutely **NO TOUCHING** the people on the hayride. Do not get close to the tractors.
- 👤 Absolutely **NO REAL PROPS**. (i.e. weapons, blood, etc.)
- 👤 Stay at your scenes or scene vicinity. Please do not follow the trailer & disturb the next scene. Remember you are actors for those on the hayride. If you leave your scene, there is no act for visitors to see.
- 👤 All concession food is for purchase only. We will have food available for volunteers at the mandatory meeting.
- 👤 There are portable toilets located in the woods just off the hayride trail. Please use these instead of the public bathrooms as you will be in costume and need to stay in the woods.
- 👤 There will be solar lights along the edge of the hayride trail. Please do not remove or relocate lights as they are needed for the tractor drivers to negotiate the trail.
